## 8. Terms of payment

- Above prices apply per consignment/exhibitor.
- All services and rates must be paid before services are provided.
- For services without prior order we charge a handling fee of 20% of the total amount.
- All services must be requested at least 5 working days before the service is provided.
- The same prices apply to return shipments and services.
- Further services can be offered on request.
- The duty of care ends when the goods are left at the stand and only begins again when the goods are collected from the stand after the end of the fair both irrespective of whether the exhibitor is present or whether the shipping documents have been handed in at the DHL Service Point or to our DHL employees. Ask about the favourable conditions for insurance.
- Please note that agreed delivery times for transports are non-binding standard delivery times. The standard delivery times stated are subject, among other
  things, to the situation-related traffic situation and are to be understood as a guideline. Liability for delays can only be accepted within the framework of delivery
  date commitments agreed in writing and within the framework of the statutory provisions (CMR, HGB).

We operate exclusively on the basis of the German Freight Forwarders' Standard Terms and Conditions 2017 - ADSp 2017 - and - insofar as these do not apply to the provision of logistics services - in accordance with the Logistics General Terms and Conditions 2019. Note: The ADSp 2017 deviate from the law in clause 23 with regard to the maximum liability amount for damage to goods (§ 431 HGB) by limiting the liability to 2 SDR/kg in the case of multimodal transports including carriage by sea and in the case of an unknown place of damage, and otherwise additionally limiting the standard liability of 8.33 SDR/kg to 1.25 million euros per event of damage and 2.5 million euros per event of damage, but at least 2 SDR/kg. Insofar as the transport, storage or other handling of art objects is concerned, the General Terms and Conditions for Art ("GTC Art") shall apply as amended from time to time.
